THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MONTEBELLO WAS HELD ON WEDNESDAY, MARCH 15, 2017 AT THE MONTEBELLO COMMUNITY CENTER, 350 HAVERSTRAW ROAD, MONTEBELLO, NEW YORK. THE MEETING WAS CALLED TO ORDER AT 8:00 P.M. FOLLOWED BY THE PLEDGE OF ALLEGIANCE.

Mayor's Report:

Mayor Millman shared that with Blizzard Stella that hit our area clean-up was completed in a timely manner. Unfortunately, one of our carter's trucks hit a telephone pole causing a road closure for several hours.

Parks Commission:

With no one present to speak, Mayor Millman closed this portion of the meeting.

Public Comment:

With no one present to speak, Mayor Millman closed this portion of the meeting.

The Mayor offered the floor to Joshua Hinkley, 2 Grist Mill Court, Montebello to discuss his project.

Joshua shared that he is a Life Scout of Troop 2021 in Suffern and a Sophomore in Suffern High School. Joshua is looking to build, as an Eagle Scout project, a greenhouse complete with wooden frame and side panels made from recycled two-liter bottles. The greenhouse would have a concrete floor with the dimension of about 8x8. The Village Attorney after praising the offer, made inquiry whether this type of construction would survive weather in the North East. Discussion ensued and the Village Board advised Mr. Hinkley that it is impressed and quite interested, thanked him for his offer, and stated that he will be contacted within the next two weeks after further discussion of feasibility.

Mayor Millman asked Commission Chairperson, Trustee Melanie Golden, to give an overview of the Interim Report of the Comprehensive Plan Commission.

Trustee Golden and Planner Max Stach discussed in detail the timeline associated with the adoption of the 2009 plan and the implementation of Phase I thereof. Unfortunately, Phase II including the following important portions was not implemented: Adoption of a "Greenprint", identifying open space and environmental assets, especially fragile environmental sources requiring special protection. Designating various Environmental Protection Overlay Districts (EPOD'S); and, establishing aquifer, water resources map for aquifer protection.

As the Planner and Chairperson went on to explain, the proposed 2009 maps have been updated, and adopting implementing regulations in the form of amendments to our Village Code must be drawn and approved. Chairperson Golden also pointed out that these aspects of the plan were so essential that the vestige of same even appended in 2003 Plan, and that when Phase I was presented to the Rockland County Planning Department in 2010, it made inquiry back about implementation of these aspects of the Plan.

Upon inquiry about costs the Planner indicated a cost between about \$5,500 and \$7,500, and confirmed that even with such cost included, the \$20,000 budgeted for the Plan in 2017 will not become exhausted.
