WHEREAS, a public hearing has been held to consider adding Chapter 83 to the Village Code, entitled "Filmmaking", allowing filmmaking within the Village of Montebello, providing for a permitting process under controlled conditions, and assuring oversight by the Village and the Town of Ramapo Police Department especially for reasons of traffic control and safety; and

The Law also has a fee structure, and a fining structure if someone were to film without a permit.

Attorney Berbit advised that General Code offered minor suggestions, which were incorporated, but, overall it, approved of the Law, which was patterned after a recent enaction in Wesley Hills, with improvements. Attorney Berbit also added that at this point, Rockland County has not had the opportunity to respond. The Local Law will be held then filed after their response is received.

With no other questions or concerns, at 10:05 pm Trustee Sorrillo made a motion to close the Public Hearing, seconded by Deputy Mayor Caridi, all in favor.

WHEREAS, the Village Attorney made a presentation summarizing the proposed law; and

WHEREAS, the Village Attorney requested that the following be included in the record:

WHEREAS, Trustee Sorrillo moved and Deputy Mayor Caridi seconded presenting the proposed Local Law for adoption; and

WHEREAS, the Board duly deliberated in public, and made the following changes to the proposed Local Law:

1. Added a provision requiring notice to abutting property owners; and

THEREFORE, BE IT RESOLVED that the Local Law be adopted with the above change, such not to be filed with the Secretary of State until the action of the Rockland County Department of Planning was received and reviewed, and assuming that no aspect of same needed to be overridden by the Village Board or until the 30 days to respond has expired.
