Title: To Reduce the Speed Limit on New York State Route 202

WHEREAS, the Village Board of the Village of Montebello has received concerns about the speed limit on New York State Route 202, which, within the Village, has tragically witnessed several accidents including fatalities within recent years; and

WHEREAS, the residents have also voiced concerns over vehicles and commercial vehicles not abiding by the posted speed limit in the Village of Montebello causing a public safety issue as exacerbated by limited sight lines from and to intersecting roads; and

WHEREAS, in addition there are school and religious institutions and a Senior Center accessing Route 202 directly, and access to the Village's Dr. Jeffrey Oppenheim Community Center, as well as many residential driveways accessing Route 202 within the Village; and

WHEREAS, drivers attempting to enter the road from all these varied connections face the prospect of having to commit to and reach highway speeds with no on-ramps in a very short time frame; and

WHEREAS, as aforementioned, the accident history of this road surely supports the need for a speed limit that recognizes the numerous locations that traffic enters the road and limited sight lines; and

WHEREAS, such has been the subject of meetings with elected officials and in communicating with other Villages.

THEREFORE, BE IT RESOLVED, that the Village Board of the Village of Montebello fully supports any and all efforts to reduce the speed limit on State Route 202 in the areas where it passes through the Village as well as outside that area to better control speed within the Village; and

BE IT FURTHER RESOLVED that the Village Board of the Village of Montebello requests that the Village Clerk-Treasurer of the Village of Montebello send a certified copy of this Resolution to the New York State Department of Transportation, as well as to any involved elected officials.
