Preceding the regular meeting of the Board of Trustees was a Budget workshop that was held at 6:00 P.M. The Regular meeting of the Board of Trustees began at 7:00 P.M.

Mayor's Report:

Mayor Millman stated that we are still pursuing the traffic studies for Mile Road and Montebello Road as well as speed reduction on Route 202 with Senator Bill Weber. Rockland County Highway has cleared a better sightline on the corner of Mile and Montebello Road in the interim to hopefully deter accidents.

Mayor Millman stated that the Village is still in discussions with the Cell Tower company as well as Enbridge (pipeline).

Mayor Millman stated that with it getting darker earlier, to please watch for walkers in the roadway and for walkers to wear some sort of reflective clothing for safety.

Building Department Report:

The following is the Building Department Report for the month of September 2023:

- (10) building permits were filed. A total of \$13,312.00 in permit fees were collected.
- (6) Certificates of Occupancy were issued.
- (16) locations were inspected/reinspected; \$4,912.50 in Fire Inspection fees were collected during the month.
- (10) code violations were issued.

Historic Preservation and Parks Commission (HPPC)

Chairperson Lisa Levin sent in the following report:

- W3R sign installation is ongoing, coordinating with County and State Highway departments.
- 2023 Certificate of Appropriateness hearings status:
 103 Montebello Road Date of initial public hearing: March 1, 2023
 ONGOING (Public hearing remains open). Unanimous HPPC conditional approval of COA was granted at HPPC regular meeting on October 4, 2023. The Village Attorney is drafting the resolution and, upon final approval of resolution by members, COA will be issued.
- Martin Spence has conducted a survey of work to be done at KGPP and has sent it out to bid. So far, the bids are astronomical and unachievable in pricing (well over \$100K) and Joan is waiting for the balance of these bids to come in. Will have to be a budgeted/granted item and will need to get approval to be added to the budget. As of now, it is a project for the 2024 season as the scope is enormous
- New KGPP park landscaping bids for 2024 have been send out (the current landscaper has not been doing enough around the ponds). Additional work was also added in that area.
- The park bench in honor of Tony Piazza has been delivered. Currently out for bid to have the footings installed. Hoping bidding process will be completed shortly and will then schedule an "unveiling" for Tony.
- Assistant Building Inspector and Groundskeeper have been walking the trails at KGPP, especially the Daniel Beard trail on a weekly basis, and have been finding evidence of camping and fire rings in that area. HPPC has been made aware of this and have been instructed to notify RPD immediately if anyone sees anything suspicious.

With no one from the HPPC in attendance, Mayor Millman closed this portion of the meeting.
