Mayor's Report:

Mayor Millman spoke about a proposal before the Board from an Eagle Scout to install Bat Houses for his Eagle project. This will be discussed further into the meeting.

Mayor Millman discussed the major water main break on Kings Gate last night. It was a double break in the line and the fourth one in two years. The new water company, Veolia, is looking into the problem. They have begun repairing residents' properties as the water has been turned off.

The Mayor reminds everyone to call the Police if you see anything suspicious.

Mayor Millman explained that the old Novartis Property, which is now or soon will be owned by Brookfield Properties, that Old Mill Road which went up for auction by the Thruway Authority was not won by Brookfield Properties.

Mayor Millman stated that Cornell Cooperative Extension has summer education programs available as webinars and for more information please go to their website.

Mayor Millman advised that Lake Welch is still closed as well as a few other parks and lakes and people should contact the facility before heading there.

Mayor Millman would like to welcome new Trustee Dr. David Liebergall.

Building Department Report:

The following is the Building Department Report for the month of June 2022:

- (9) building permits were filed. A total of \$4,642.00 in permit fees were collected.
- (7) Certificates of Occupancy were issued.
- (6) locations were reinspected; \$825.00 in Fire Inspection fees were collected during the month.
- (9) code violations were issued.

Historic Preservation and Parks Commission (HPPC)

Village Attorney Berbit stated THE HPPC is in the midst of public hearings for Certificates of Appropriateness for two properties, the Ryan Mansion at Montebello Road opposite Hemion, for renovation of the exterior; and, due to being on a Historic Road, the vacant parcel at 131 Spook Rock Road upon which a new home is proposed. The HPPC is to meet in the field on the former to look at materials and the front doors. The latter was approved for a Certificate subject to 1) gathering the loose stones on the property formerly comprising a wall to recreate the semblance of a wall across the frontage to the extent possible without importing more stone and, 2) to plant and create a native species vegetative buffer approximately 28' in depth along the frontage of the property. With no one additionally from the HPPC wishing to speak, Mayor Millman closed this portion of the meeting.

Public Comment:

Even though there were people from the public in the audience, no one from the public wishing to speak, Mayor Millman closed this portion of the meeting.

Presentation: Stonehedge

Mr. Marsel Amona discussed with the Board his proposal to reduce the units and vary their appearance for the Stonehedge Property the Public Hearing on which has been held in abeyance. Discussions ensued with Mr. Amona, Mayor, and Board. Albeit the proposed changes were similar to those viewed as insufficient before

Ms. Peggy Kurtz of Rockland Community Power was asked to explain why advertisements by the company stated Montebello has joined versus Montebello is considering joining Rockland Community Power. Mayor Millman explained that residents are concerned that a decision was made before they were instructed.

Mayor Millman explained that Rockland Community Power needs to do more advertising about the program and has suggested that they attend the Suffern Street Fair and advertise for not only Suffern but Montebello.
