#### **Presentation:** Marsel Amona – Stonehedge

Marsel Amona informally discussed his revisited plans for the Stonehedge Project which had been withdrawn from consideration months ago.

Briefly, now he is proposing a 3-lot subdivision with the Minetto house and caretaker cottage on one lot, 3 single family homes in fee ownership on a second, and 8 duplexes (16 homes) on a third lot with condominium status. He claimed he could not drop below 4,048 SF per duplex home, including basement and garages. The basement would be a mix of storage with 6' 2" ceiling max and portions with approximately 8' ceilings. The proposed three 3' x 2' basement windows for light and ventilation, but no egress windows or doors, and no below grade sleeping. He also proposed adding 500 SF to one side of the duplex units, which was quickly rejected by the Mayor and the Board. As to the rest, the Village's professionals will review and comment upon Mr. Amona's plans as and when submitted (after additional details are submitted).

#### Resolution No. 23 - 097

Title: Veolia Water New York Inc. PSC Case # 23-W-0111

WHEREAS, as brought to the attention of the Village of Montebello by Chris Kear, Director of Fire and Emergency Services of Rockland County in his communication received June 15, 2023, Veolia's application before the Public Service Commission (PSC) not only seeks a rate hike of about 14%, but in an addendum added by leaf 28 No. 1.6 seeks to add an exculpatory section D. which essentially absolves Veolia of any and all consequences or liability for insufficient water pressure, capacity, loss by fire, or otherwise; and

WHEREAS, in the opinion of said Director, such is totally unacceptable as it absolves Veolia from any responsibility for the failure of its water system to provide adequate pressure or capacity, even in emergencies wherein insufficiency or inadequacy potentially threatens life and property; and

WHEREAS, by virtue of Resolution No. 256 of 2023 of the Rockland County Legislature, referred to as a fully set forth hereinafter, said Legislature unanimously opposed the Veolia application to the PSC for the reasons set forth therein; and

WHEREAS, the Village Fire Inspector and the Village Attorney concur with the aforesaid positions of the Legislature and Fire Director in recommending that the Village Board oppose Veolia's application to the PSC in its entirety, including the addendum, for the above reasons in belief that not only is said rate increase unjustified and excessive, but also in firm opposition to the provision absolving Veolia's responsibility for inadequate water services and pressure at all times, even during emergencies, representing a potential risk to public health and safety, and to property.

THEREFORE, BE IT RESOLVED, that the Village Board of the Village of Montebello hereby opposes said application and directs that this Resolution be filed with the PSC along with copies distributed to Veolia, the Rockland County Legislature, and all other parties of interest. Motion: Trustee Golden
