### **The applicant must understand and agree to the following conditions:**

1. This application must be filled out *no less than 5 business days* prior to the date of the open burn.
2. The open burn must be attended at all times by the individual listed above under 'supervising'.
3. A copy of this permit must be available at all times during the open burn.
4. A copy of this permit must be provided to anyone whom requests to view it.
5. The site of open burn is subject to inspection by the Fire Inspector, local Fire Chief or anyone having legal jurisdiction within the Village of Montebello. This may be prior to, during or after burn.
6. The open burn shall *never* be left unattended at any time unless completely extinguished.
7. An open burn shall not be conducted during a period of High Fire Danger as announced by the DHSES-Fire Prevention & control, the NYS DEC, Rockland County OES, or any other agency.
8. This permit is not transferable and is only valid to the applicant listed above.
9. Must comply with the *International Fire code; Section 307-Open Burning:*
  - 307.4.2-Recreational Fires: Shall not be conducted within 25' of a structure or combustible material. Conditions that could cause a fire to spread within 25' of a structure shall be eliminated prior to ignition.*
  - 307.4-Attendance: Open burning; bon fires or recreational fires shall be constantly attended to until the fire is extinguished. A minimum of 1 fire extinguisher with a 4A rating or other approved onsite fire equipment, such as loose dirt, sand, garden hose, or water truck shall be made available.*
10. Must comply with *Section 89-18 Bonfires and outdoor rubbish fires* of the Code of the Village of Montebello.
11. The Fire Inspector will notify 44-Control (fire dispatch), Ramapo Police and local Fire Chief of open burn.
12. A diagram/sketch of the fire location in relation to any structures must be provided on rear of this application.
